AEMO has published a notice of consultation on proposed changes to the Wholesale Market Distribution Unaccounted for Gas (UAFG) Procedures (Victoria).

## **Proposed procedure changes:**

- Amend the formula for the average volume weighted market price in the Procedure.
- Align the formula with the formula for the Unaccounted for Gas reconciliation amount in item C2 of Part C of Schedule 1 of Victorian Gas Distribution System Code (the Code).
- Allow a DUAFG year to be split into DUAFG periods with the same benchmark values for a supply point class and distributor
